1. Objectives

6. Eligibility

Candidate applicants must satisfy the following requirements:

(1) Nationality: Must be Citizens of Myanmar

(2) Age: Should be **between the ages 22 and 40 as of 1st April, 2025. (Born on/after 2nd April, 1985 and on/before 1st April, 2003)**

(3) Occupation:

1) **Have a full-time job an experience for 2 years or more**

2) Take long-term leave and return to the workplace after studying

3) Have awareness of social responsibility, and willing to contribute to the development of private sector of Myanmar and network with Japan.

(5) Academic Background: Must hold a bachelor's degree

(6) English Proficiency: **IELTS 6.5 or TOFEL PBT 550 or TOFEL iBT 80 or TOEIC 800**

(7) Study in Japan: **Must enroll in September 2025 in a Master's program at a Japanese university**

(8) Participation in the MJC project: **Must have taken the MJC Business courses or be executives of the companies that have taken the MJC program.**

(Those who have taken related business management courses at UMFCCI are also eligible.)

Candidates must be selected through MJC's internal selection procedure (By MJC Selection Committee) and must pass the general entrance examination of the university they have applied to, including examinations to enter the applicants' desired master's degree.
